

Registration

To sign up, you need to go to the www.timau.space and press the "Create account" button.

New Here? Create Account


Then enter your E-mail. Now you need to agree with the "Terms&Conditions". Then click "Submit"




After that you will see this page. You need to check your mail. The link comes immediately. Usually it takes no more than a couple of minutes.




The E-mail you receive looks like this. You will be informed that a new user with your login has been created. Below you can see the confirmation link. You need to click it.




After you click on the link, you need to come up with a password. Enter it, then confirm. Then press the "Submit" button.




Now you see the text that your password has been successfully created. Press the "Homepage" button.



Now you are on the login page. To continue your registration, you need to sign in to your account. Enter your login and password. Then press "Enter" button.




When you enter login (email) and password, you must complete Google Verification.




At the beginning, you need to download the Google Authenticator application. Next, open the application and click on the "multicolored plus" at the bottom right. Now we have two options:

- 1. Scan the QR code.
- 2. Enter the key.




Both options are possible here. Now the code, that you have to enter in the field, will appear in the application.



Enter it quickly because the code changes. After the code changes, the old one is no longer valid. After you did all this, press the button



When you have entered your personal account, you will have access only to some features, such as the dashboard. To get full access, you must complete the registration with identity verification. To do this, click on any section that is not available yet, for example, one of the wallet sections. You'll see a widget like this. Now you can continue with the mobile version. This is made for your convenience because the camera on the phone has better quality, therefore it will be much easier to complete your identity confirmation on this device. Usually, cameras on the desktop have low quality, and thus there may arise problems with scanning and photo. However, this is not necessary, you can continue verification on your desktop. To continue with the desktop, click "Continue". To open the website on your mobile device quickly, you need to scan the QR code using your phone.

On the next page you will find a text about consent for your personal data processing. Be sure to read.







Consent for personal data processing

In order to obtain the service from the Service Provider, with this consent I express my agreement that UAB "Ondato" will receive and manage my personal data, including my biometric data, gained from remote identification of my personal identity by taking and/or filming live image of my face, my person's identity or the document used to identify it and/or their image and the personal data contained in them and/or check in the population registry: image of my face, name, surname, nationality, gender, personal code, date of birth, numbers of the document that is being used, date of issue and validity, my signature and the transfer of such data to the Service Provider. I also note that I am informed that the controller of my personal data, including my biometric data, specified in this consent is the Service Provider and UAB "Ondato" will process my personal data only until the remote identification procedure is over and the results will be transferred to the Service Provider. I also declare that I am informed and agree that my personal data obtained for remote identification and its purposes may be stored by UAB "Ondato" for longer period of time than it takes for the identification to be completed or transmission of its results to the Service Provider, but only at the request of the Service Provider or UAB Ondato's contractual obligation to the Service Provider, but not longer than it is defined in the Contract that was signed between UAB "Ondato" and Service Provider or requested by the Service Provider. I am informed, that I can submit request regarding my personal data for more detailed information at info@ondato.com. Hereby I declare and confirm, that all the personal data I will provide for remote identification of my personal identity purpose, are correct and accurate, and the document, which I will use for this purpose is not false and valid.




To continue, we need your consent to process your personal data.

Now you need to select the type of document you can provide as confirmation of your identity.

Select the document



After selecting a document you will see conditions, which must match. the photo of the document.




Press the "Start" button and prepare to take a photo of your identity card or passport. Your document must be readable! When you have found a good position for the document, click the "Capture" button. After that, you will see your picture. You need to evaluate it and if something does not match the required conditions, redo it. If everything is fine, then continue.



Processing please wait

The processing may take a couple of minutes.

When the data processing is complete, you have to scan your face. Read the identification recommendations



Press the «Start» button.

Now you need to take a picture. You have to give permission for using the camera on your device.




When the camera starts scanning, you must follow the on-screen instructions. After your face has been scanned and the data processing begins, it is very important not to close the browser window or switch to other websites, otherwise, you will have to start this step again.

Now the first step is complete.



Once the first step is complete, you must complete the second step. You can complete it right after the first step or you need click on one of the still closed sections.

This picture shows that the first step has already been successfully completed.



However, it also may be possible that the first-step data has not been updated and the status has not changed to the "active" yet. In this case, you can still start the second step.



To start the next step, please click



On the next page you will see a new widget. Very important! Write your real address here, otherwise, registration will not pass. The document must be in English! Let's figure out, what address confirmation is. After you have entered your country, city, address and ZIP code, you need to upload a document confirmation. This can be any bills or official letters. Remember that your name on this document must match the name on the document you provided earlier. The format of the document must be *.pdf, *.jpeg, *.png. The maximum size is 2 MB.



If you have passed identification using a mobile device and you need to return to your desktop, then, after you fill out all fields and select the file, you need to press the "Edit data" button. Now you should return to the desktop. You need to close the website on the mobile device. After the registration process is complete, you will see a widget like this in your personal account. Both steps must have "Active" status to gain full access to your personal account.
